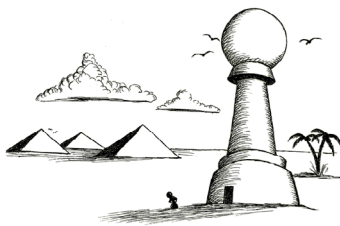


# Chess Academy of Denver – August Tournament

**DIVISION:** Rated: K-12 (Current USCF membership required); Time control G/30

**TIMES:** Check-in 8:00-8:15 a.m. Players Meeting (all competitors must attend) 8:15 a.m.; first round starts when everyone is present or at 8:30 a.m., whichever is earliest. The event will finish early to mid-afternoon. **5 Rounds** – Swiss-system

**PRIZES:** Trophies to top finishers; class and team trophies may be added, depending on size and distribution of tournament.

**LUNCH:** Bring your own sack lunch – we will eat around noon, after Round 3 or 4, depending on length of rounds.

**GAME ANALYSIS:** National Master Todd Bardwick will do game analysis for interested participants. Learn personally from Colorado's most experienced chess teacher. Please bring your chess clock; chess boards are supplied.
